- C. NEW BUSINESS: Seedling order from State Forestry Nursery: Ordering opened December 1st, M. Hill placed an order for 70 seedlings on December 2nd at a cost of \$120.00. We will pick them up in May from the Rockingham County Complex. The order consisted of 10 each of Red Oak, Paper Birch, Button Bush, Winterberry Holly, Common Elderberry, American Larch and Norway Spruce.

D. OTHER BUSINESS

- **a. Greenhead traps: M.** Hill contacted Sarah McGregor at Dragon to say we wanted to hire them to maintain our Greenhead traps. M. Hill also spoke with the Town Administrator about buying a shopping container for storing the traps. She said we should use the Conservation Fund to pay for the container. The Recreation Commission purchased theirs from Mobile Mini in Salisbury. It cost \$4,900 plus a \$200 delivery charge. S. Hanson thought we could find one less expensive. We will check other prices.
- **b. RCCD donation of marsh parcels:** S. Hanson contacted Mary Ganz writing up a sample deed for the 5 parcels. The sample she provided was reviewed. The sample deed would be given to the Board of Selectmen for their approval, and sent back to RCCD.
- **c. Citizens Guide**: A. Reis has address labels and a brief note to send with the Homeowner Guides to new residents in Town.
- **d.** Plaque for Glenn Schrempf: C. Golas has the design and names of companies who make placques. More discussion on style.
- **e.** Conservation Commission logo sign: M. Hill will contact Brianna about getting the logo sign made.
