ROAD PAVING 2020

He pointed out that he feels this is a hate crime and asked the Board to condemn the vandalism. The Chair read a statement regarding this. R. Dirsa said that the Police Department is working on the case and the state Attorney General will be investigating this as a hate crime.

Members of the Parks and Recreation Commission were present to report that the Town Common Bandstand roof project has begun.

The Board Chair and Town Administrator met with the DOT in September to discuss different kinds of signs or putting in an island to slow traffic for safety reasons. Driver feedback signs were discussed as a solution. The Chair asked the Police Chief to provide pricing for two driver feedback signs.

PARKS AND RECREATION COMMISSION (The Depot)

Members of the Parks and Recreation Commission were present to discuss the Monday meeting with Primex regarding risk and liability at "The Depot". The Parks and Recreation Commission asked Primex if some signs would be feasible and included the Police Chief in the discussion and at the site visit. Primex recommended a safety swimming sign, hours of operation, site rules.

The Board requested the Parks and Recreation Commission draft an ordinance for consideration of the Board, working with the Police Chief (and Town Counsel). Chief Dirsa spoke to the Board about the feasibility of controlling the traffic at the Depot.

BRUSH DUMP FENCING

The Board discussed putting in a stockade fence to improve the view and solve other issues. The Board would like to investigate pricing for this. The Road Agent will measure the length for the Board.
