SOLID WASTE DISPOSAL OPPORTUNITIES

Household Bulky Waste Disposal Days

Household bulky waste disposal is coming back! The Town received the required permit from the State and has made some changes to the Household Bulky Waste Disposal Days. Rather than twice-per-year, disposal of bulky items can be done <u>on</u> the first Saturday of each month, beginning May 6, 2023, through October 7, 2023 (for a total of six-6-Saturdays). Residents will need a valid Brush Dump Sticker (\$30.00 for 3-years) and pre-pay for the disposal at the Town Clerk's Office (open Mon-Wed 8am-3:30pm, and Thurs 8am-6pm, closed Fridays).

The fees remain the same as last year, with a per trip fee of \$20.00 and/or a cost-per-item fee for items for which the Town incurs additional costs. These fees must be **prepaid** at the Town Clerk's Office where a receipt will be provided to show the Brush Dump Attendant. If <u>only</u> bringing an item with a specific fee (such as electronics, tires, mattresses, wood, propane tanks or items containing freon) no trip fee (\$20.00) is charged, only the cost-per-item fee. 

The Town is planning to have a "swap" area available on the first Saturday of the month, and are looking for Volunteers to help with that.



The Town of Hampton Falls has benefited from a grant sponsored by the Town's disposal contractor, Covanta Energy. A



Universal Waste Shed is located at the Town's Brush Dump for the purpose of collecting certain products containing mercury; specifically, thermostats, mercury switches, florescent lamps, button cell batteries and alkaline batteries.

Residents can also dispose these items by participating in the Town of Hampton's annual Hazardous Waste Collection Day on May 20, 2023. Thank you for your help in disposing of these items in a safe manner and protecting the environment!

HAZARDOUS WASTE DISPOSAL: Hampton Falls' residents have

the opportunity to properly dispose of certain Hazardous Waste items by participating in the **Town of Hampton**, **NH** collection days: **Saturday**, **May 20**, **2023 and Saturday**, **September 16**, **2023 from 8 am to Noon** at the Hampton Transfer Station, 1 Hardardt's Way, Hampton, NH.

Requirements include, but are not limited to, a **\$31 fee per vehicle**, <u>prepaid</u> to the Hampton Falls Town Clerk/Tax Collector, with a limit of up to five (5) gallons or twenty (20) pounds of waste or the combination of the two; this being the maximum amount allowed. IT'S REVALUATION TIME IN HAMPTON FALLS

Market value, assessed value, revaluation, statistical update.... these terms will all be heard frequently over the next few months in Hampton Falls. That is because Hampton Falls has recently started the first phase of the property revaluation as required by the Department of Revenue Administration (DRA). The goal is to have the Town's assessed values at 100% of the market value. Currently, Hampton Falls property values are at 64% of fair market value, based on the State's equalization study. The revaluation is not as simple as adding 36% to all the property values. The values of different types of properties and neighborhoods (land, residential, multi-family, commercial, etc.) have all changed by different percentages. Smaller homes have increased in value more than the larger homes over the past five years. The last statistical revaluation was done five years ago. This revaluation is considered a full revaluation, meaning that the Town's assessing vendor, Avitar Associates, as well as the DRA, will be in the neighborhoods looking at properties, taking pictures and carefully reviewing the sales of properties over the past year.

When people hear that their property value is increasing, it does not mean that a higher tax bill will occur. The Town knows that Hampton Falls' average assessed values are lower than they should be. When the value of property increases, the tax rate decreases, and the amount of taxes one pays remains approximately the same. Some may see a higher bill, others a lower bill, while the majority will see only a very slight change. As the revaluation work progresses, residents will receive a letter with their proposed new value in July and an opportunity to discuss the new value with the contractor in August. The DRA will do a random selection of properties to verify the town's accuracy of data. Residents receiving Elderly Exemptions or Veteran's Credits have already been contacted to verify their qualifications. Properties in "Current Use" are currently being reviewed for accuracy as well. When the DRA is satisfied that Hampton Falls' revaluation data is correct,



the DRA will certify the property values. The certified property values will be used to determine the 2023 Hampton Falls' tax rate, based on the budgets that were approved at the Town and School District Meetings in March 2023.

In New Hampshire, the assessed value of individual properties does not change each year; assessed property values are only adjusted during periodic revaluations or when physical changes are made to the property. To determine the "market value," recent sales in the community and the factors that effected the value of the property are analyzed, such as the location, type of construction, and size. The Assessor then evaluates supplemental data, such as commercial reports on the cost of construction for the region, circumstances regarding particular sales and any other information that may impact property values. It is not a scientific, exact process. It is a logical process that uses the best information available at the time to determine fair market value. It is important to recognize that "market value" is *as of a certain point in time*, April 1st, 2023 for this current process.

CAUTION – TURTLE CROSSING



Every Spring, Turtles, Salamanders, Frogs, and Toads migrate to Vernal Breeding Pools on "*Big Nights*" — evenings when temperatures are around 40-degrees or higher and it is raining. This usually happens between mid-April through early May in Hampton Falls. Turtles are on the move when the weather gets warm and are often seen slowly crossing a road. They have well established home ranges and do not wander too far. The best thing to do is to leave the turtle alone. If it is a dangerous situation with lots of vehicles, and you can do so safely, carefully put it across the road in the same direction it was heading.

Drivers can help these creatures cross safely by paying attention and trying to avoid these small creatures that may crossing the road. If you know of a particular area that sees this activity frequently, please let the Hampton Falls Conservation Commission know so that the area can be highlighted for drivers.

2023 DOG LICENSES:

The 2023 dog tags are available from the Town Clerk's office (in person or on-line). ALL DOGS IN TOWN SHOULD BE LICENSED BY APRIL 30 each year as required by state RSA 466:1. Rabies vaccination certificate(s) are only required if rabies expiration date has expired. Each dog not licensed by May 31 will automatically receive an additional \$25 civil forfeiture fine(RSA 466:13). If you no longer own a dog(s), call 1-603-926-4618; Ext. 101 or 106, or E-mail us at townclerkcollect@hamptonfalls.org; and we will remove your name from the list.

<u>FILING FOR A MARRIAGE LICENSE:</u> Please call ahead to schedule an appointment to apply for a new marriage license. Please note the appointment will take about 45-minutes. Any New Hampshire Town or City Clerk can do the filing for a marriage license. The cost is \$50 and requires both persons' I.D. and final divorce or death certificates, if filing for a subsequent marriage other than your first.

<u>VITAL RECORDS AND 3-YEAR - DUMP STICKERS ON-LINE:</u> You can request "certified" copies of NH Birth, Death, Marriage, and Divorce certificates on-line by choosing Vital Records on the town web page, please also email a picture of your driver's license when requesting any certified copy to <u>townclerkcollect@hamptonfalls.org</u>. Requests for self-cling, 3-year brush dump stickers are available on-line or from the Town Clerk's office at a cost of \$30 each.

<u>TOWN CLERK'S OFFICE CLOSED TO THE PUBLIC FRIDAYS:</u> A reminder that the Town Clerk's office is closed to the public on Fridays.

<u>TAX INFORMATION:</u> *IMPORTANT!* Many of you are using online banking, please schedule your payment to arrive on or before the due date. Most systems require 5-6 days to deliver a payment. **Please do not postdate your check**; by law the Tax Collector cannot hold your check in the office until the posted check date. The check will be returned if the check is postdated and could result in the payment being late and incurring interest.

The first tax bill for 2023 will be mailed in May and will be due in July. As an alternate to mailing your payment, you can deposit a check in the exterior drop box, located to the left of the Town Hall front entrance. If you would like a receipt, please provide a self-addressed, stamped envelope. You can also make payments online at www.hamptonfalls.org. Please be aware that there is a \$0.95 bank fee for using an online check or 2.95% to use credit cards (this fee is charged by the credit card company, not by the Town of Hampton Falls).

Tax liens were executed for 2022 delinquent real estate taxes on April 12, 2023. Interest on delinquent taxes is calculated daily. Please go online or call the Town Clerk/Tax office to obtain an accurate balance due. If you have any questions regarding your real estate taxes, interest, setting up a payment schedule or need copies of your paid receipts for the IRS, please call the Town of Hampton Falls Tax Collector's office at 603-926-4618 ext. 101 or 106.

Many of you have inquired about the State claim forms for Low- and Moderate-Income Homeowners' Property Tax Relief. If you have qualified for the program in prior years, the claim form will be **sent to you** after May 1, 2023. If you would like to apply for the program and have not done so before, the (DP-8) Forms will be available in Town Hall after May 1st. Spring 2023 is here and the Hampton Falls Fire Department (HFFD) reminds you of a few items and services offered in addition to emergency, ambulance, and fire calls.

- There are single use OTC COVID tests kits for free pick-up at the Fire Station.
- Time to renew your annual/seasonal fire permits for fire pits (no bigger than 4' inside diameter), Chimineas, or other purchased portable campfire devices
 - ...brush piles still need a separate 1-day permit.
- Check your batteries in smoke and/or carbon monoxide detectors.
- Fire extinguishers should be turned upside down and shaken if they have been motionless for a long period of time and gauges should be in the 'green', units are good for about 10-years....Classes are offered on the use of fire extinguishers, if interested.
- CPR and First-aid classes are taught, if interested.
- Blood pressure checks are offered, if interested.
- Home fire safety inspection and help to develop a fire safety plan is offered, if interested.
- Information on 'emergency preparedness kits' is offered, if interested.
- Station tours / Q&A for kids of all ages are available anytime –SWAG available.
- The HFFD is on Facebook but is not monitored 24/7
- Reminder to get your fireworks permits 3-days prior to launching giving you enough time to notify your neighbors (especially the ones with animals).

Information about proper disposal of medications, boat flares, and other hazardous items.

MOSQUITO CONTROL - The mosquito control program begins in April. Crews check swamps, woodland pools, ditches, salt marshes, storm drains and other shallow, stagnant water for mosquito larvae. When mosquitoes are found, larvicides are used. We all need to do our part to protect our families from potentially life altering illnesses. The steps are

simple and only require a little diligence by making sure standing water is not allowed to pool in little, or unused items like old tires, playground equipment, sandboxes, or anything that can hold water for the larvae to breed.

Residents who do not want their wetlands treated may use Dragon Mosquito's No-Spray Registry online at www.DragonMosquito.com/No-Spray-Registry or write to Dragon Mosquito Control, PO Box 46,

Stratham, NH 03885. Be sure to include your name, physical address, phone number, and a description of your property with boundaries. Residents who would like to have their stagnant water checked for mosquitoes may call the office at 603-734-4144 or email Info@DragonMosquito.com. There is no charge for this service. Contact them for more information on spray dates, location, materials used, precautions or other concerns.

CONSIDERING A SUMMER PROJECT? - With warm weather on our doorstep, the projects we envisioned during the Winter are now on the shortlist. Before you spend your hard-earned money, remember that permits are required for most, if not all building projects in or around your home. Tell your contractors you want to see permits. They will pay more attention to work details. There are many things to factor in such as setbacks from property lines and wetlands. Adding a bedroom or accessory dwelling to your home may require a new septic design. Time must be allocated for design and approval. Do you know where your underground utilities and septic system are located before any digging is done? Call the Building Office as part of your planning process. PLEASE... To help with reviewing your application for new projects that are in the yard or increase the size of any structure, provide an <u>accurate</u> plot plan with your application showing distances to property lines or wetland areas. If you are planning a swimming pool for warmer days remember that it is a structure inclusive of any surrounding patio areas. Any required fencing around the pool is not affected by the setbacks. *You are responsible for the accuracy of the diagrams*. We can help get everything in place.

As Winter relaxes its hold on Hampton Falls, the Conservation Commission has begun preparing for Summer field work. The first event is Roadside Clean-up throughout April this year. Residents may sign-up to cover different roads, but all residents are encouraged to pick-up the roadside trash in front of their own property. Roadside Clean-Up trash bags can be placed with residents' household trash for pick-up, or, brought to the Town Brush Dump and added to the White Goods Day dumpsters.

Spring also awakens plants. Among the shrubs and trees, the invasive plants green-up early with the Spring bulbs. Honeysuckles, for example, leaf out when the Daffodils are blooming. It should be noted that while many weeds are "invasive" like Poison Ivy and Quack grass, those are native to the area and are a nuisance to gardeners, but they do not have the same impact on the environment as the non-native invasive plants. The plants that the Department of Agriculture classifies as "Invasive", are plants that were imported from Asia and Europe, and that are overwhelming Hampton Falls' native plants, creating monocultures that outcompete and smother the native plants (Oriental Bittersweet), can be poisonous to wildlife (Black Swallow-wort), and can be destructive to our homes (Oriental Bittersweet, again). The Conservation

Commission, with assistance from Summer Interns, will (again) be working to control Invasive plants at the Raspberry Farm and Depot Landing, as in Summer of 2022.

The Conservation Commission is hiring two (2) Interns for Summer 2023 to help with the following various projects. In addition to removing Invasive plants, mapping trails on Town properties will be revisited, Invasive plants' hot spots will be identified, and various maps will be added to the Town's website. The Conservation Commission will be exploring ways to correct some of the degradation occurring in the saltmarsh, while also removing Phragmites. If there is time, the Conservation Commission may try building Turtle nests near the pond at the Raspberry Farm.



The Conservation Commission is looking for new members to share the fun. Sadly, James Kibler is moving to California. James was responsible for obtaining the Conservation Easement on the Claybrook Forest, that is located on the Taylor River. Claybrook Forest is rich in wildlife and James is thanked for having the foresight and determination to preserve it. Thank you, James, for all that you did for the Conservation Commission and for the land conservation you accomplished with Claybrook Forest in Hampton Falls.

HISTORICAL SOCIETY TRUSTEES - Tracy Healey-Beattie, Chairperson

Soon the Historic Society Museum will boast a brilliant yellow backdrop when Forsythia announces its Spring arrival. The birds will be heard chirping while the rooster in the Colliander's barn demands that his authority be recognized! The Historical Society Trustees welcomes this particular Spring of 2023, as its Winter plans for the Museum have reached fruition.

What was once the library kitchen has been recreated to a much-needed Archival Room. The Trustees spent hours designing the space for historic resources and for historic items. Custom cabinets and shelving are in place, and aged linoleum was removed to reveal the original birch floor. Plaster cracks were repaired, fresh paint was applied and the result is a state of the art Archival Room! Windows throughout the Museum were removed, repaired, and restored for the purpose of preservation and to improve insulation. The former "furnace room" currently holds file cabinets and metal shelving. All of these projects are a result of fund-raising efforts. The Historical Society Trustees are most grateful to the Selectmen for awarding the monies from the Frying Pan Lane Fund for some of these projects.

On April 19th, the Historical Society co-sponsored a program, with the Library, on New England Quilts. Historical Society Trustee Spotlight: Carolyn Vatcher Petit

The history of Hampton Falls can be conveyed through books, photos, and historical artifacts, but more interesting are oral interviews, as with Carolyn Vatcher Petit. What can people learn from this lovely, articulate octogenarian and lifelong resident of Hampton Falls? Simply listening to Carolyn recall her childhood years with vivid reflection is time well-spent!

Born on August 25,1942, it was a time of unrest. She spoke of the military planes flying overhead, as told by her parents during this time of fear and vigilance. Carolyn presented a war ration book, with many remaining stamps, once used by her parents, Effie Irene Moulton and George Irving Vatcher. One of six children, the family lived on the corner of Sanborn and Exeter Road. Initially, her father bought a shed from Charlie Green, one that housed tractors and farming equipment. It was renovated for their home and then enlarged as the family grew. Unfortunately, two days after the nine eleven attacks of 2001, their house burned down. It was community members who volunteered their time, materials, and efforts to rebuild a house. An



example of this close knit and caring townspeople, Dick Merrill, former Road Agent, donated the lumber from his sawmill.

Speaking of fires, Carolyn recalled spending her first two years of school in Seabrook, because the school near the Town Common burned down. Lincoln Akerman School was built to replace the original school that burned. Students returned to LAS for lower school and then to Hampton for upper grades. Carolyn graduated from Winnacunnet High School.

Her childhood was spent roaming local fields with friends, among them, Anne Sanborn Coombs and Forest Brown. Some had bikes or road horseback to swim in local ponds and visit friends. Hampton Falls was an agricultural and safe town. It was smaller in population and neighbors watched out for each other. Most roads were a natural surface. It was not until years later when Wesley Powell became Governor that Exeter Road was paved to accommodate his travel to Concord

Carolyn remembers her father planting a great variety of fruit trees that were sold at Edgerly's farm stand, across from the Town Common. Food came from their family gardens. Eggs were sold locally but most farms had chickens and other animals. Carolyn recalls going to Batchelder's in Hampton where ice covered with sawdust was stored in the barn.

Her father would bring a selected piece of ice for their refrigerator. Families were active in 4H programs and Grange Fairs. Carolyn remembers the stage in Town Hall where plays and various programs were held by community members

Carolyn married and had four children. She worked many years as a dispatcher for the Hampton Police Department. Carolyn was also known for her culinary skills and caterer in many New Hampshire towns. As a salesperson for AVON products, she enjoyed meeting many folks beyond Hampton Falls.

Carolyn has served as a Trustee for the Hampton Falls Historical Society for many years. In this capacity, she has contributed so much historical background for the membership. Her favorite project was working on the replica dollhouse of the Warren Brown homestead. Recently, Carolyn Vatcher Petit was given the recognition of Honorary Member of the Historical Society. Health issues have prevented Carolyn from being actively involved, but this woman, endeared by all, will be at the Museum in the near future, ready to answer your questions about the Town she fondly calls home. The Historical Society Trustees honor this kind, gracious and knowledgeable woman of Hampton Falls.

Weather-related repairs: The older wing of LAS experienced damage due to a burst pipe Winter 22/23, and this has required closing access to that building wing. Liability insurance along with expendable trust will cover the cost of all repairs. All repairs have been completed and the space is taking shape nicely, undergoing final steps in preparation for classes to move back in soon.

Student Leadership team: Superintendent Nadeau is working with two 7th and 8th grade students from LAS, along with students from the other SAU 21 schools, in a Student Leadership Team. Students meet monthly to learn about school operations and offer their input.

Enhanced communication: The School Board is excited to see the long-term public communications sign come to reality. This sign will help the school communicate important safety, school and community updates.

Cost Efficiencies: The HF School District will receive approximately \$7,000 in annual revenue as a result of a Net-Metering group of Unitil customers with Briar Hydro, based on past KwH usage and rates. This facilitates the sharing and allocation of Net-Metering Credits generated by a Net-Metering facility. The group receives credits, (payment received from Unitil) for any surplus generation. Additionally, the New Hampshire Retirement System (NHRS) issued Hampton Falls a refund of \$34,983.09 this fiscal year. This was a result of HB1221, a bill that was passed in 2022 to provide a one-time NHRS employer contribution reimbursement.

SAU21 wide Strategy: The SAU 21 administration is building their *Portrait of a Learner Strategy* to guide curriculum and extracurricular offerings moving forward. All community members are invited to public meetings to contribute to the process. Visit the www.SAU21.org website for more information.
