SOLID WASTE DISPOSAL OPPORTUNITIES

The Town's **Household Waste Collection Day** is scheduled for Saturday **May 15**, 8 am to 2 pm at the Hampton Falls Brush Dump at the corner of Drinkwater and Parsonage Roads.

Dump stickers are not required for this Household Waste Disposal Day; instead, a **\$20 per trip fee** will be charged.



DISPOSAL OF CERTAIN PRODUCTS CONTAINING MERCURY (Hg)

The Town of Hampton Falls has benefited from a grant sponsored by the Town's disposal contractor, Covanta Energy. A Universal Waste Shed is located at the Town's Brush Dump for the purpose of collecting certain products containing mercury; specifically, thermostats, mercury switches, florescent lamps, button cell batteries and alkaline batteries.



Residents can also dispose these items during the annual Household Hazardous Waste Collection Day on May 22. Thank you for your help in disposing of these items in a safe manner and protecting the environment!

HAZARDOUS WASTE DISPOSAL

Hampton Falls' residents have the opportunity to properly dispose of certain Hazardous Waste items by participating in the **Town of Hampton**, **NH** collection day(s). The dates of the 2021 collections are **Saturday**, **May 22**, and **Saturday**, **September 18 from 8 am to Noon** at the Hampton Transfer Station, 11 Hardardt's Way, Hampton, NH.

Requirements include, but are not limited to, a \$29 fee per vehicle, *prepaid* to the Hampton Falls Town Clerk/Tax Collector, with a limit of up to five (5) gallons or twenty (20) pounds of waste or the combination of the two; this being the maximum amount allowed. Rabies vaccination certificate(s) are only required if rabies expiration date has expired. **Each dog not licensed by May 31 will automatically receive an additional \$25 civil forfeiture (RSA)**

VEHICLE REGISTRATION INFORMATION

You may use the following procedures and utilize the exterior drop box. If you have bought a new vehicle/trailer/motorcycle. Please provide the following:

- Copy of your driver's license
- Title or Title Application (Town Clerk copy at the bottom)
- Contact information (name, phone number and email)
- Payment (check made out to Town of Hampton Falls and we will fill in amount or credit card over the phone once processed)

Please put this information in an envelope and **utilize our drop box** outside, to the left of the Town Hall door. We will process and call you to arrange a time to pick up the plates at our outside window.

Any residents who wish to transfer their old plates to a new vehicle please provide the following:

- Copy of your driver's license
- Old registration (the plates you wish to transfer must be original not a copy)
- Title or Title Application (Town Clerk Copy)
- Blank check (once filled in we will copy and send back to you)
- Contact information (email, phone # and address)

Please put this information in an envelope and **utilize our drop box** outside, to the left of the Town Hall door. We will process and mail back to you.

We ask you that you continue to renew your registrations online as well as licensing dogs. Please visit the Town Clerk's page on www.hamptonfalls.org to renew online. You may also renew your vehicle by dropping off a copy of your previous registration, copy of your license and a payment (please see above) and deliver to the outside drop box. You can also call into the office to process a renewal over the phone, or come in and renew.

FILING FOR A MARRIAGE LICENSE

Please call ahead to schedule an appointment to apply for a new marriage license. Please note the appointment will take about 45 minutes. Any New Hampshire Town or City Clerk can do the filing for a marriage license. The cost is \$50 and requires both persons' I.D. and final divorce or death certificates if filing for a subsequent marriage other than your first.

VITAL RECORDS AND 3-YEAR - DUMP STICKERS ON-LINE

You can request "certified" copies of NH Birth, Death, Marriage and Divorce certificates on-line by choosing Vital Records on the town web page, please also email a picture of your driver's license when requesting any certified copy to townclerkcollect@hamptonfalls.org. Limited staff prevents us from being able to produce certified copies "on the spot." Requests for self-cling, 3-year brush dump stickers (required for brush disposal only; no longer required for household waste collection days) are available on-line or from the Town Clerk's office at a cost of \$30 each.

TAX INFORMATION

IMPORTANT! Many of you are using online banking, please schedule your payment to arrive on or before the due date. Most systems require 5 - 6 days to deliver a payment. **Please do not postdate your check**, by law we cannot hold your check in the office until the posted check date. The check will be returned to you if the check is postdated and could result in the payment being late and incurring interest.

The first tax bill for 2021 will be mailed in May and will be due in July. As an alternate to mailing your payment, you can deposit a check in the exterior drop box, located to the left of the Town Hall front entrance. If you would like a receipt, please provide us with a self-addressed, stamped envelope.

You can also make payments online at www.hamptonfalls.org. Please be aware that there is a \$0.95 bank fee for using an online check or 2.95% to use credit cards (this fee is charged by the credit card company not by the Town of Hampton Falls).

Tax liens were executed for 2020 delinquent taxes on April 13, 2020. Interest on delinquent taxes is calculated daily. Please go online or call this office to obtain an accurate balance due. If you have any questions regarding your taxes, interest, setting up a payment schedule or need copies of your paid receipts for the IRS, please call the tax office at 603-926-4618 ext. 101 or 106.

Many of you have inquired about the State claim forms for Low- and Moderate-Income Homeowners Property Tax Relief. If you have qualified for the program in prior years, the claim form will be **sent to you** after May 1, 2021. If you would like to apply for the program and have not done so before, the (DP-8) Forms will be available in Town Hall after May 1st. Spring is here and we remind you of a few items and other services that HFFD offers besides emergency ambulance and fires calls.

- Time to renew your annual fire permits for fire pits, Chimineas, or portable fire rings (brush piles still need a separate 1-day permit).
- Check your batteries in smoke and/or carbon monoxide detectors.
- Fire extinguishers should be turned upside down and shaken if they have been motionless for a long period of time and gauges should be in the 'green.'
- We teach CPR and First-aid classes.
- We offer blood pressure checks and baby seat vehicle installations.
- We will do a home fire safety inspection and help you develop a fire safety plan.
- Provide information on 'emergency preparedness kits.'
- We offer fire extinguisher classes.
- Station tours / Q&A for kids of all ages are available anytime.

MOSQUITO CONTROL - The mosquito control program begins in April. Crews check swamps, woodland pools, ditches, salt marshes, storm drains and other shallow, stagnant water for mosquito larvae. When mosquitoes are found, insecticides are used. We all need to do our part to protect our families from this potentially life altering illness. The steps are simple and only require a little diligence by making sure standing water is not allowed to pool in little, or unused items like old tires, playground equipment, sandboxes, or anything that can hold water for the larvae to breed.

Residents who do not want their wetlands treated may use Dragon Mosquito's No-Spray Registry online at www.DragonMosquito.com/No-Spray-Registry or write to Dragon Mosquito Control, PO Box 46, Stratham, NH 03885. Be sure to include your name, physical address, phone number, and a description of your property with boundaries. Residents who would like to have their stagnant water checked for mosquitoes may call the office at 603-734-4144 or email Info@DragonMosquito.com. There is no charge for this service. Contact them for more information on spray dates, location, materials used, precautions or other concerns.

CONSIDERING A SUMMER PROJECT? - With warm weather on our doorstep, the projects we envisioned during the winter are now on the shortlist. Before you spend your hard-earned money, remember that permits are required for most, if not all building projects in or around your home. There are many things to factor in such as setbacks from property lines and wetlands. Adding a bedroom or accessory dwelling to your home may require a new septic design. Time must be allocated for design and approval. Do you know where your underground utilities and septic system are located before any digging is done? Call the building office as part of the planning process. PLEASE... To help with reviewing your application for new projects that are in the yard or increase the size of any structure, provide an accurate plot plan with your application

CONSERVATION COMMISSION – Mary Ann Hill, Chair

Meets the second Tuesday of the month at 6:30 at Town Hall

Welcome spring by taking a stroll through the <u>Marsh Lane Preserve</u>. Watch for the emerging Jack-in-the-Pulpit and Indian Pipe along the trail. Look for the new sign on Route 1 indicating the location of the Marsh Lane area. We will be asking for volunteers to help control the Oriental Bittersweet which is overtaking the parking area.

We held our first work day of the season on the **Raspberry Farm/Town Forest trail** extending the trail deeper into the forest. We will have more work days coming up to work on the invasive plants along the margin of the field. Join us and learn about Oriental Bittersweet, Multifloral Rose, Buckthorn and more.

We are pleased to announce that the <u>conservation easement on the Clay Brook Forest</u> (<u>Toppan Lane Ox Pasture</u>) is fully funded thanks to Grants from ARM, LCHIP, VF Corp, and various fundraising activities. On February 12th Senator Tom Sherman presented the Kiblers, the Town and the Forest Society with a Senate Resolution in recognition of their successful effort to preserve this choice ecological location.

SHEA, the Seabrook-Hamptons Estuary Alliance, continues to work on an estuary management plan and presented three on-line workshops on the Salt Marsh studying the functions of the marsh, the effects of sea level rise, the after effects of the old practice of ditching, threats to the birds which rely on the marsh and marsh migration. They are hosting a "Birds of the Estuary" webinar on April 21st. Look for the details on their website www.shea4nh.org and also on our Town's website at www.hamptonfalls.org/conservation-commission/files/birds-estuary-april-212021.

We are trying something new this year. We have posted a <u>Summer Internship</u> on the Town website and also with UNH's Handshake. We are looking for college students interested in Ecology to assist us in those projects we talk about but never seem to get to like controlling the Bittersweet or creating a pollinator garden at the Raspberry Farm. See our Town website for more information.

We encourage residents to find our trails and enjoy a leisurely walk with nature. Bobolinks will be nesting at the Raspberry Farm, and interesting plants like Jack in the Pulpits and Indian Pipes (yes, they are a plant and not a mushroom!) can be found at Marsh Lane. Do remember to leave only your footprints behind.
