PRC Roles and Responsibilities - Proposed Changes

As discussed in prior PRC monthly meetings, the Select Board expressed an interest in assuming the property management responsibilities currently being performed by the PRC. A brief document was prepared and distributed before this meeting which outlined what that change in role might look like. At this meeting extensive discussion took place regarding the role the PRC should play regarding property management. Input from Larry Smith and Alex Dittami indicated the RSA clearly states the Commission has the authority to manage properties that come under its purview, in particular, Governor Weare Park and the Town Common. A suggestion was made that we needed to decide whether we wanted to go forward with the property management responsibilities. The best way to move forward would be to clarify the 'as is' situation on which properties are included, what programs are currently in place, what programs are planned in the near future, a detailed review of this year's budget and a review of the property management projects in the queue. A workshop was planned for November 7 at 6:pm to work on these topics. We will need to confirm the Town Hall is available at that time. Documentation to be distributed beforehand should include the 2022 budget details, list of projects in the queue, properties currently under the Commission's purview, list of current and proposed programs and their associated costs.
